 - Sponsorship only available to States

- Call for applications
 - 1st: 22 November 2018 07 December 2018
 - 2nd: 04 February 2019 12 February 2019
 - 3rd: 13 May 2019 03 June 2019
- 'rolling process'
- Application requirements
 - Nominate <u>one</u> delegate only
 - Submit:
 - completed application form
 - note verbale confirming nomination
 - copy of passport



Decision-making process



- ATT Secretariat prepared shortlist of eligible applicants
 - Submitted by deadline
 - Submitted application documents
 - Draft selection criteria applied
- MC considered and approved shortlist
- Donors consulted




Overview of sponsored StatesBy region




Applications approved

Overview of sponsored delegates By Gender


