# REPORT ON THE ATT MANAGEMENT COMMITTEE'S ACTIVITIES FOR THE PERIOD 2021/2022

### **INTRODUCTION**

- 1. The Management Committee is established as a subsidiary body under Article 17(4) of the Arms Trade Treaty as well as Rule 42 of the Rules of Procedure, to provide oversight on financial matters as well as other matters related to the ATT Secretariat with the aim of ensuring maximum accountability, efficiency and transparency.
- 2. This report is submitted by the ATT Management Committee in accordance with its reporting obligation to the Conference of States Parties contemplated in Rule 42(3) of the Rules of Procedure of the Arms Trade Treaty and Section 12 of its own Terms of Reference.

# **COMPOSITION OF THE MANAGEMENT COMMITTEE**

- 3. The Management Committee is chaired by the President of the Eighth Conference of States Parties (CSP8), Ambassador Thomas GÖBEL, Permanent Representative of the Federal Republic of Germany to the Conference on Disarmament in Geneva, and is composed of five States Party representatives designated by the United Nations regional groups and appointed by the Seventh Conference of States Parties (CSP7). The current Management Committee members are: Costa Rica, the Czech Republic, the Republic of Korea, United Kingdom of Great Britain and Northern Ireland and South Africa.
- 4. Section 3 of the Management Committee's Terms of Reference specifies that, with the exception of the President of the Conference of States Parties and the representative of the ATT Secretariat, members of the Committee shall serve for a period of two years and are eligible to serve a further term. Accordingly, the term of the current Management Committee will run until the Ninth Conference of States Parties (CSP9).

# **MANDATE**

5. The mandate of the Management Committee is to provide oversight on financial matters as well as other matters related to the ATT Secretariat with the aim of ensuring maximum accountability, efficiency and transparency. The Management Committee's mandate is elaborated in its Terms of Reference, referenced ATT/CSP1/CONF/4.

# **METHOD OF WORK**

- 6. In performing its work, the Management Committee relies on the provisions of the Treaty, its Terms of Reference, the Directive of States Parties to the ATT Secretariat and decisions taken by Conferences of States Parties related to its mandate.
- 7. The Management Committee conducts its work, its meetings and takes decisions in accordance with the provisions of the ATT Rules of Procedures with particular reference to Rules 42 and 43.
- 8. The Management Committee conducts its work through formal meetings as well as exchange of documents through emails. Summaries of the Management Committee's meetings are published on the restricted part of the ATT website for access by States Parties throughout the year.

### MANAGEMENT COMMITTEE DELIVERABLES AND ACTIVITIES

- 9. In the reporting period, the Management Committee held one (1) formal meeting in Geneva, Switzerland. In addition, the Management Committee participated in joint meetings with the Bureau and other ATT office holders regarding the format of the CSP8 informal preparatory meetings and CSP8 itself, in response to the COVID-19 evolution.
- 10. In executing its mandate and decisions of Conferences of States Parties, the Management Committee undertook the following activities:
  - a. Developed its programme of work for the year based on its mandate.
  - b. Provided oversight over the process for the issuance of invoices in October 2021 to States for financial contributions to the ATT 2022 budget as adopted by CSP7.
  - c. Provided oversight over the procurement of interpretation and translation services for ATT meetings through the multi-year contractual framework.
  - d. Provided oversight over the process for the notification of States of their outstanding assessed financial contributions in March 2022.
  - e. Elaborated a practical procedure to implement the Guidelines for Financial Arrangements under Financial Rule 8 (1)d), as adopted by CSP7.
  - f. Pursuant to Rule 4 (1) of the ATT Financial Rules and Section 10 of its own Terms of Reference, the Management Committee reviewed the 2023 budget estimates for the ATT Secretariat and CSP9 prior to their submission to States Parties by the ATT Secretariat.
  - g. Prepared its report to CSP8 outlining activities undertaken by the Management Committee in the period between CSP7 and CSP8.

### **BUDGETARY IMPLICATIONS**

11. In undertaking its responsibilities during the period under review, the Management Committee did not incur any financial expenditure to be carried by the ATT budget.
