### ANNOUNCEMENT PERTAINING TO THE CSP5: ATT OFFICE HOLDERS AND SCHEDULE OF MEETINGS

1. In my capacity as the President of the Fifth Conference of States Parties (CSP5) to the Arms Trade Treaty (ATT) and with the support of the CSP5 Vice-Presidents, we write to inform you of the appointment of the Chairs of the ATT Working Groups as well as the Chairperson of the Voluntary Trust Fund (VTF) Selection Committee, and to notify you of the schedule of meetings for the CSP5 informal preparatory process and the CSP itself.

### **ATT Working Group Chairs**

2. The Working Group on Effective Treaty Implementation (WGETI), Working Group on Transparency and Reporting (WGTR), and the Working Group on Treaty Universalization (WGTU) will be chaired as follows:

a. WGETI: Ambassador Sabrina DALLAFIOR, of Switzerland with a possibility to appoint

facilitators for the various topics under this Working Group.

b. WGTR: Ms. Katya CORTÉS MARTÍNEZ, of Mexico; and

Mr. Tom NIJS, of Belgium.

c. WGTU: Ambassador Nobushige TAKAMIZAWA, of Japan; and

Ambassador Jānis KĀRKLIŅŠ, of Latvia.

3. We would like to take this opportunity to thank fellow Co-Chairs for undertaking to carry forward the important work of the ATT Working Groups, and we are confident that meaningful progress will be made by all the Working Groups under their capable stewardship.

### Chairman of the VTF Selection Committee

4. During the first meeting of the VTF Selection Committee members appointed during CSP4, the VTF Selection Committee members selected Ambassador Peter BEERWERTH of Germany to serve as Chairman of the VTF Selection Committee until CSP5, and Ambassador Dell HIGGIE of New Zealand to serve as Chairman of the VTF Selection Committee from CSP5 to CSP6.

### Schedule of Meetings

- 5. Following existing practice, the Bureau suggests to prepare for CSP5 by organizing two (2) informal preparatory meetings in the intersessional period before CSP5 and by holding the meetings of the Working Groups to coincide with the informal preparatory meetings in order to facilitate and maximize participation in the meetings.

  - b. Matrix for the evaluation of the ATT Secretariat's performance on the administration of the sponsorship programme at CSP6.
  - c. Options to address problems related to financial liquidity, including the feasibility of establishing a reserve fund.
  - d. Proposal to address the problem of assessed financial contributions in accordance with the Financial Rules.
  - e. Regional representation in the context of the Terms of Reference of the Management Committee.
  - f. Proposal on possible expansion of Management Committee membership.
- 9. The Bureau looks forward to working with you all in the weeks and months ahead towards a successful CSP5 and to sharing further details of its work plan and vision for the Conference as they unfold.
