1. Project activities and outcomes

a Describe the project outcomes.

1- Le projet de renforcement des capacités des personnels des agences d'exécution sur les obligations de rapportage de l'article 13 du TCA a été réalisé à travers un atelier qui a eu lieu du 28 au 30 mai 2024 à l'Hôtel El Shaddai d'Adéticopé (préfecture d'Agoè-nyivé). Deux (2) experts internationaux provenant du Bénin et du Burkina-Faso et un (01) expert national ont été recrutés dans le cadre de l'exécution dudit projet.

Les experts internationaux étaient chargés de préparer et de développer les communications inscrites à l'agenda et l'expert national avait pour mission de faire le suivi et l'évaluation de la conduite du projet.

2- L'atelier a pour objectif le renforcement des capacités des personnels des agences d'exécution en vue de leur permettre de remplir leurs obligations en matière de rapportage conformément à l'article 13 du TCA.

Spécifiquement, il s'agit de :

- permettre aux participants d'assimiler les procédures et pratiques en matière d'établissement de rapports au titre du TCA ;
- ancrer l'effectivité de l'établissement du rapport annuel et de maintenir la fréquence d'envoi au Secrétariat du TCA en termes de reddition des comptes vis-à-vis des autres Etats parties ;
- améliorer la chaîne de coordination, de communication et de coopération interagence en matière d'établissement de rapports ;
- éviter le détournement des armes, objet de transfert.

3-Les participants sont issus des structures suivantes : Douanes, Forces Armées, Police Nationale, ministères chargés de la Justice, des Affaires Etrangères, du Commerce, des Transports, de l'Economie maritime et des Ressources Forestières, ainsi que la Commission nationale sur les armes légères.

4-L'activité s'est déroulée sous un format de communications et d'exercices pratiques tirés des expériences du Bénin et du Burkina-Faso. Trois (03) interventions ont marqué la cérémonie d'ouverture des travaux. Le mot de bienvenue du Secrétaire Général de la préfecture d'Agoè-Nyivé, Monsieur Kazandou Essohana, l'allocution du Vice-Président de la Commission nationale de lutte contre la prolifération, la circulation et le trafic illicites des armes légères et de petit calibre (CNLPAL), Monsieur Bouraïma Inoussa et le discours d'ouverture du Ministre de la Sécurité et de la Protection Civile, l'Ambassadeur Calixte B. Madjoulba.

5-Durant les trois (03) jours des travaux, cinq (05) communications ont été présentées sur les thèmes suivants :

- Présentation des objectifs de l'activité ;
- Aperçu général du Traité sur le Commerce des Armes (TCA) et rapportage ;
- Exigences et pratiques du rapportage (rapport initial et rapport annuel) ;
- Mise en place d'un mécanisme national de rapportage ;
- Conservation des données.

A l'issue de ces communications, les participants ont été soumis à un exercice pratique à travers des travaux de groupe sur le modèle de rapport proposé par la 7ème conférence des Etats parties. Les résultats des travaux de groupe ont été restitués en séance plénière.

6- Des recommandations ont été formulées et portent, notamment sur :

- l'instauration d'un cadre de concertation entre les différentes agences d'exécution en vue de la collecte des données relatives au rapportage ;
- la sensibilisation des personnels des différentes unités impliquées dans le processus de rapportage en termes d'échange d'informations ;
- l'initiation d'un séminaire gouvernemental au sujet de l'obligation de rapportage consacrée par le TCA et les autres textes pertinents relatifs aux armes classiques.

7- L'activité a fait l'objet d'évaluation par l'expert national en suivi-évaluation.

Une première phase d'évaluation du projet a été menée à travers la distribution d'une fiche d'évaluation de l'atelier aux participants en vue de recueillir leurs impressions.

La seconde phase d'évaluation s'est faite à travers des entretiens individuels menés auprès des participants quelques semaines après la fin de l'atelier afin de se rendre compte des retombées du projet.

Cette évaluation a permis d'analyser les connaissances et compétences acquises par les participants suite à l'atelier et de cerner l'impact.

8- La visibilité du projet a été assurée par une couverture médiatique (radio, télé, média en ligne, presse écrite), la confection des blocs-notes et de banderoles comportant les logos du bailleur (ATT - VTF).

Le projet a permis d'actualiser les connaissances pour certains acteurs de mise en œuvre et de renforcer les compétences pour d'autres en matière d'établissement de rapports annuels. Sur la base des éléments indiquant la pertinence du projet, on peut en déduire que les différentes communications inscrites à l'agenda, ainsi que les techniques d'enseignement ont favorisé l'apprentissage au cours des trois (3) jours de l'atelier. Les exercices pratiques ont permis d'améliorer les compétences et les niveaux de connaissances des participants.

Ainsi :

- 95% des participants ont démontré une connaissance claire des obligations spécifiques du Togo en matière de rapportage, des catégories d'informations à collecter et des délais impartis ;
- 85% des participants ont compris les procédures et les outils mis à disposition par le Secrétariat du TCA pour faciliter la préparation des rapports.
- Les évaluations individuelles révèlent que 100% des participants ont acquis une compréhension claire des concepts clés liés aux obligations de rapportage de l'article 13 du TCA.
- Les participants ont démontré leur capacité à interpréter correctement les dispositions pertinentes de l'article 13 du TCA et à identifier les obligations spécifiques du Togo en matière

de rapportage.

- Une forte mobilisation des médias autour de l'événement a été notée ;
- Une appréciation positive du choix des thèmes développés par les experts a été exprimée.

Le délai d'exécution du projet a été repoussé compte tenu du calendrier politique électoral auquel le Togo faisait face. En effet, le pays a organisé un double scrutin comprenant les élections législatives et régionales au mois d'avril 2024. Ce fait politique majeur a conduit à un report de l'activité un mois plus tard, notamment les 28, 29 et 30 mai 2024.

S'agissant des dépenses engagées, elles sont globalement restées dans la fourchette des montants prévus dans le budget approuvé.

Au vu de ces éléments d'appréciation, on peut relever le caractère efficient du projet dans sa mise en œuvre.

En effet, 95% des participants ont exprimé leur satisfaction quant à la qualité de la formation et à sa pertinence pour leur travail quotidien. Ainsi, l'atelier de renforcement des capacités a permis de :

- **améliorer la compréhension des exigences de rapportage de l'article 13**, notamment les types de données requises et les formats de rapport.
- **promouvoir une meilleure coordination et collaboration entre les différentes entités nationales** impliquées dans le processus de rapportage.
- **renforcer la volonté politique** à travers la sensibilisation sur l'importance du rapportage sur le TCA.

1. Project activities and outcomes

a Describe the project outcomes.

- 1- The project to strengthen the capacities of the staff of the implementing agencies on the reporting obligations of Article 13 of the ATT was carried out through a workshop that took place from 28 to 30 May 2024 at the EI Shaddai Hotel in Adéticopé (Agoè-nyivé prefecture). Two (2) international experts from Benin and Burkina Faso and one (01) national expert have been recruited as part of the implementation of this project. The international experts were responsible for preparing and developing the papers on the agenda and the national expert was responsible for monitoring and evaluating the conduct of the project.
- 2- The objective of the workshop is to strengthen the capacities of the staff of the implementing agencies to enable them to fulfil their reporting obligations in accordance with Article 13 of the ATT. Specifically, these are:
- Enable participants to assimilate ATT reporting procedures and practices;
 - anchor the effectiveness of the preparation of the annual report and maintain the frequency of sending to the Secretariat of the ATT in terms of accountability to other States Parties ;
 - Improving the chain of coordination, communication and inter-agency cooperation on reporting;
 - to prevent the diversion of weapons, which are the object of transfer.
- 3- The participants come from the following structures: Customs, Armed Forces, National Police, Ministries of Justice, Foreign Affairs, Trade, Transport, Maritime Economy and Forest Resources, as well as the National Commission on Small Arms.

The activity took place in a format of presentations and practical exercises drawn from the experiences of Benin and Burkina Faso. Three (03) interventions marked the opening ceremony of the work. The welcome word of the Secretary General of the prefecture of Agoè-Nyivé, Mr. Kazandou Essohana, the speech of the Vice-President of the National Commission for the Fight against the Proliferation, Illicit Circulation and Trafficking of Small Arms and Light Weapons (CNLPAL), Mr. Bouraïma Inoussa and the opening speech of the Minister of Security and Civil Protection, Ambassador Calixte B. Madjoulba.

- 4- During the three (03) days of the work, five (05) papers were presented on the following themes:
- Presentation of the objectives of the activity;
 - Overview of the Arms Trade Treaty (ATT) and reporting;
 - Reporting requirements and practices (initial and annual reports);
 - Establishment of a national reporting mechanism;
 - Data Retention.

At the end of these papers, the participants were subjected to a practical exercise through group work on the report model proposed by the 7th Conference of States Parties. The results of the group's work were presented to the plenary session.

6- Recommendations were made and include:

- the establishment of a framework for consultation between the various implementing agencies with a view to collecting data relating to reporting;
- raising awareness among the staff of the various units involved in the reporting process in terms of information exchange;
- the initiation of a government seminar on the reporting obligation enshrined in the ATT and other relevant texts relating to conventional arms.

7- The activity was evaluated by the national expert in monitoring and evaluation.

A first phase of evaluation of the project was carried out through the distribution of an evaluation sheet of the workshop to the participants in order to collect their impressions. The second phase of evaluation was carried out through individual interviews conducted with the participants a few weeks after the end of the workshop in order to assess the impact of the project. This evaluation made it possible to analyse the knowledge and skills acquired by the participants following the workshop as a result.

8- The visibility of the project was ensured by media coverage (radio, television, online media, written press), the making of notepads and banners bearing the logos of the donor (ATT - VTF).

The project updated knowledge for some implementers and strengthened annual reporting skills for others. Thus, the relevance was felt during the exchanges and discussions. The responses provided by the participants at the end of the evaluation phase are a good illustration of the state of mind.

The majority of respondents (participants) stated that the content of the training was in line with their needs, expectations and concerns. To this end, they have committed themselves to using the knowledge acquired for a better accomplishment of their missions. The project also provided an opportunity to exchange on challenges and good practices encountered in the national context as well as the experiences of other States Parties, including Benin and Burkina Faso.

Based on the elements indicating the relevance of the project, it can be deduced that the various papers on the agenda, as well as the teaching techniques, promoted learning during the three (3) days of the workshop. The practical exercises improved the skills and knowledge levels of the participants.

Thus:

- 95% of participants demonstrated a clear knowledge of Togo's specific reporting obligations, the categories of information to be collected and the deadlines set;
- 85% of participants understood the procedures and tools made available by the ATT Secretariat to facilitate the preparation of reports.
- Individual evaluations reveal that 100% of participants have gained a clear understanding of key concepts related to reporting obligations of Article 13 of the ATT

The deadline for the implementation of the project was postponed in view of the electoral political calendar that Togo was facing. Indeed, the country has organized a double election including legislative and regional elections in April 2024. This major political event led to a postponement of activity a month later, notably on 28, 29 and 30 May 2024.

Expenditures incurred remained broadly within the approved budget.

In view of these factors, it can be noted that the project is efficient in its implementation.


