INVITATION TO TENDER: REMOTE SIMULTANEOUS INTERPRETATION SERVICES FOR THE ATT SECRETARIAT

The Arms Trade Treaty (ATT) Secretariat is pleased to invite you to tender for the provision of Remote Simultaneous Interpretation (RSI) services in Arabic, Chinese, English, French, Russian and Spanish.

This tender seeks to establish a contractual framework for the remote provision of interpretation services in support of the annual Conference of States Parties (CSP) and its preparatory meetings. Services may include plenary sessions, side events, and other official meetings convened by the Secretariat.

Please note that the Secretariat has already launched a separate tender process for in-person interpretation services. The present call concerns remote interpretation only.

Following the close and evaluation of both tender processes, the Secretariat will compare the technical and financial results and will determine which modality - in-person or remote - offers the best overall value for money and operational suitability for the period 2026-2028. Only one modality might be selected and contracted on that basis.

Bidders are therefore invited to submit proposals with the understanding that award of this tender will depend on the outcome of the comparative assessment of both processes.

The attached tender documents describe how to submit proposals and how such proposals will be evaluated for suitability. You are requested to submit your proposals in accordance with all the instructions, requirements and specifications set out in the enclosed documents.

The tender will open on 09 October 2025 from 13h00 and will close on 08 November 2025 at 17h00 (CET). All proposals must be submitted electronically to info@thearmstradetreaty.org by the set date and time.

The successful tenderer (service provider) will be required to deliver services in accordance with all tender requirements and contract placed with the successful tenderer (service provider). The contract will be managed according to terms and conditions agreed upon and will be subject to continuous performance review by the ATT Secretariat. The successful tenderer (service provider) shall be required to perform consistently throughout the duration of the contract. Failure to do so may result in the contract being reviewed or terminated.

The ATT Secretariat reserves the right not to contract or to contract only in part with any tenderer (service provider).

SECTION 2 - The Arms Trade Treaty (ATT) Secretariat

To help you in developing your response to our Invitation, we would like to inform you about our business so that you can use this information to inform every aspect of your application and tell us exactly why we should choose you to help us realise our business objectives.

The ATT Secretariat is an international organization established to assist States Parties in the effective implementation of the Arms Trade Treaty (ATT), by undertaking the following specific responsibilities set out in Art 18 (3) of the Treaty:

- Provide substantive and administrative support to the ATT process;
- Receive, make available and distribute the reports as mandated by the Treaty;
- Maintain and make available to States Parties the list of points of contact;
- Facilitate the matching of offers of and requests for assistance for Treaty implementation and promote international cooperation as requested;
- Facilitate the work of the Conference of States Parties, including making arrangements and providing the necessary services for meetings under the Treaty;
- Perform any other duties as decided by the Conference of States Parties; and
- Support Treaty implementation at a national level.

In addition, the ATT Secretariat serves as the Administrator of the ATT Voluntary Trust Fund (VTF), a facility established to give effect to international assistance, through the deposit and disbursement of funds, to support States in implementing their obligations under the Treaty. In this regard, the ATT Secretariat performs, amongst others, the following functions:

- Implement the VTF administrative rules and processes;
- Develop, maintain and review processes for annual call for financial contributions to the VTF;
- Develop, maintain and review processes for managing relations with donors. This entails
 concluding agreements with donors and providing donors with relevant donations
 disbursement reports and other relevant information as required;
- Develop, maintain and review processes for annual calls for contributions and calls for project proposals;
- Receive and pre-screen project proposals for compliance with the set technical application procedure and/or eligibility criteria as contemplated in the VTF Terms of Reference;
- Develop and maintain processes for managing relations with VTF beneficiaries. This
 entails concluding agreements with grant recipients setting out all applicable grants'
 terms and conditions including recipient reporting obligations;
- Monitor projects according to adopted project monitoring standards and ensure the evaluation of their outcomes;
- Prepare, publish and maintain VTF annual substantive and financial reports.

Furthermore, the ATT Secretariat is entrusted with the overall management of the ATT sponsorship programme, including managing the sponsorship funds, in the selection of the delegates to be sponsored, and technical management.

SECTION 3 - Scope of Procurement and Specifications

Scope

This Invitation to Tender covers the provision of Remote Simultaneous Interpretation (RSI) services for the conduct of yearly Conference of States Parties (CSP) or/and one or two series of preparatory meetings organized by the ATT Secretariat.

- Location: This invitation for tender is for meetings to be held in Geneva, Switzerland.
- **Dates:** The yearly Conference of States Parties usually takes place in August and is announced one year in advance. The preparatory meetings take place in the first half of a calendar year and are determined at least 2 months in advance. Our next conference, the Twelfth Conference of States Parties to the ATT, is scheduled to take place from 24 28 August 2026 in Geneva, Switzerland.
- **Duration**: A Conference of States Parties is usually scheduled for five days. The preparatory meetings are usually scheduled between two to four days. These number of days should be regarded as indicative.
- *Timetable of meetings*: The meeting days of a Conference or a preparatory meeting consist of a morning session (10:00-13:00) and an afternoon session (15:00-18:00).
- **Subject matter:** The Arms Trade Treaty (ATT) is an international Treaty that regulates the international trade in conventional arms and seeks to prevent and eradicate illicit trade and diversion of conventional arms by establishing international standards governing arms transfers. The Conferences of States Parties and the preparatory meetings are dedicated to discussions and information exchange on the effective implementation of the ATT. Tenderers are invited to visit the ATT Secretariat's website to get an idea of the nature of discussions and exchange taking place during the meetings (www.thearmstradetreaty.org).

The Secretariat is conducting two parallel tender processes:

- One for in-person interpretation services; and
- This present one for remote interpretation services.

The purpose of running both processes concurrently is to enable the Secretariat to evaluate, on a comparable basis, the technical quality, cost-effectiveness, reliability and operational feasibility of each modality. After completing the evaluations, the Secretariat might select one single approach either in-person or remote - for use during the forthcoming framework period (2026-2028).

Tenderers should therefore prepare their proposals on the understanding that:

- This call relates exclusively to remote interpretation;
- The Secretariat will make a comparative assessment of the in-person and remote bids before any contract is awarded; and
- The Secretariat may decide not to proceed with a contract under this RSI tender if the in-person solution is deemed preferable overall.

The selected service provider (should the remote modality be chosen) will deliver professional simultaneous interpretation via remote platforms in all six official ATT languages, ensuring secure, high-quality, real-time multilingual communication during ATT meetings, whether conducted entirely online or in hybrid form.

The ATT Secretariat seeks a high quality service provider that will deliver a service that is demonstrably qualified for and focused around the needs of the ATT Secretariat. Applicants are requested to study the required specifications in detail and ensure that the specified requirements can be met in an economic and timely manner by any tender submitted. The target audience for interpretation is the diplomatic corps engaged in multilateral discourse.

The ATT Secretariat reserves the right to cancel the procedure if it fails to satisfy the needs for which it was launched.

Required Specifications

The specifications of the required remote interpretation services are listed below:

- Type of interpretation: Remote Simultaneous
- Languages: The languages used at the ATT meetings may include Arabic, Chinese, English, French, Russian and Spanish. Interpretation services will be required accordingly, based on the final selection of languages.
- Capacity required: The service provider must confirm the availability of a sufficient number of interpreters to cover the interpretation from and into all languages specified above for the duration of the meetings.
- **Technical setup:** The ATT Secretariat does not possess any remote interpretation equipment or specific platform. The selected service provider must therefore provide the complete technical solution, including the RSI platform, connection interface, interpreter consoles, and all related technical support needed to ensure seamless delivery. The used platform must comply with information security standards.
- **Quality requirements:** The quality of the interpretation must be such that the audience can easily follow discussions in each of the languages specified above. Terminology and lexis must be consistent with relevant reference material.

SECTION 4 - Procurement Process

This procurement exercise is conducted in accordance with the open tender method as prescribed in the ATT Secretariat Procurement Policy.

SECTION 5 - Evaluation Criteria

Proposals submitted will be assessed on the basis of the following evaluation criteria:

Stage 1: Proposals will be checked to ensure that they have been completed correctly and all necessary information has been provided. Any proposal not correctly completed in accordance with the set requirements and/or containing omissions shall be rejected at this point. Where a proposal is rejected at this point it will automatically be disqualified and will not be further evaluated. Proposals correctly completed with all relevant information provided will proceed to Stage 2.

Stage 2: If a proposal succeeds in passing Stage 1 of the evaluation, then it will have its details evaluated in accordance with the evaluation methodology described below.

<u>Scoring Model</u> -In scoring responses to the questions above, the evaluation panel will use the following scoring model:

Points	Interpretation	
10	Excellent - Overall the response demonstrates that the applicant meets all areas of the criteria and provides all of the areas evidence requested in the level of detail requested. This, therefore, is a detailed excellent response that meets all aspects of the criteria leaving no ambiguity as to whether the applicant can meet the requirement.	
7	Good - Overall the response demonstrates that the applicant meets all areas of the requirement and provides all of the areas of evidence requested, but contains some trivial omissions in relation to the level of detail requested in terms of either the response or the evidence. This, therefore, is a good response that meets all aspects of the requirement with only a trivial level ambiguity due the applicant 's failure to provide all information at the level of detail requested.	
5	Adequate - Overall the response demonstrates that the applicant meets all areas of the requirement, but not all of the areas of evidence requested have been provided. This, therefore, is an adequate response, but with some limited ambiguity as to whether the applicant can meet the requirement due to the applicant 's failure to provide all of the evidence requested.	
3	Poor - The response does not demonstrate that the applicant meets the requirement in one or more areas. This, therefore, is a poor response with significant ambiguity as to whether the applicant can meet the requirement due to the failure by the applicant to show that it meets one or more areas of the requirement.	
0	Unacceptable - The response is non-compliant with the requirements of the tender.	

Price Information Criteria

The Price criteria carries a weighting of 40 % of the overall achievable score. The tenderer (service provider) must provide an economically sound, innovative and commercially attractive proposal offering outstanding customer service and satisfaction. Furthermore,

- Prices submitted as part of this tender must remain open for acceptance for a minimum of 60 days from the closing date for the receipt of proposals.
- Prices must be indicated per interpreter, language and day and must include preparation time as well as statutory taxes and social security contributions.
- Prices must be inclusive of all costs and be expressed in CHF.
- Prices must be inclusive of VAT.
- The prices will be fixed for the duration of the contract.
- Tenderers (service providers) must demonstrate how their proposals represent overall value for money and how they will assist the ATT Secretariat with cost containment initiatives.
- Prices must not be subject to any pricing assumptions, qualifications or indexation not explicitly provided for.
- The ATT Secretariat may reject any proposal where the overall price for the services is considered by the ATT Secretariat to be abnormally low following the relevant processes set out in this tender.

Moderation of Proposals

The evaluation panel appointed for this procurement will agree and moderate scores for each evaluation criteria. Final scores in terms of a percentage of the overall tender score will be obtained by applying the relevant factors set out as part of the evaluation criteria. The percentage scores for each evaluation criteria will be amalgamated to give a percentage score out of 100 %.

The Winning Proposal

The winning proposal shall be the highest-scoring offer under this remote interpretation tender. Following evaluation of both the in-person and remote tenders, the ATT Secretariat will compare the results and select **the most appropriate modality** for contract award.

SECTION 6 - PROCUREMENT AND PROJECT SCHEDULE

The proposed schedule for the procurement process is provided below. However, the dates indicated, except for the proposals submission date, should be regarded as indicative at this stage as the ATT Secretariat reserves the right to extend and / or amend the schedule as necessary. Any changes will be discussed with the winning applicant.

Management and reporting will be agreed in liaison with the successful tenderer (service provider).
