1. Project activities and outcomes

a Describe the project outcomes

The project took place in five (5) phases.

The results of phases 1 to 4 of the two (2) training workshops on the safe and secure management of stocks of arms and ammunition for the benefit of the agents concerned are as follows:

Phase 1: Preparatory phase: Contacts made with stakeholders - Workshops locations identified

Phase 2: Identification of participants Result: List of participants obtained

Phase 3: Identification of the experts Result: Signature of contracts with the experts

Phase 4: Workshop logistics Results: Deployment of logistics

- Concretely, the participants were identified in each region from the invitations sent and the responses received;

- Experts / trainers have been identified and their consulting contracts have been negotiated;

- Logistics for workshops in the regions have been put in place (workshop locations and accommodation identified and reserved; participant transport provided, training documents prepared and made available to participants, etc.).

The results of phase 5 of the two (2) workshops:

Phase 5: Carrying out the workshops Results: Number of participants trained - Level of appreciation of the training

Two (2) three (3) day workshops, one in the South and the other in the North, were held and were each attended by fifty (50) gunsmiths (i.e. 100 participants). These gunsmiths were made up of soldiers and paramilitaries and came from the following structures: ministry of armies, customs, police, gendarmerie, prison administration, water and forest, firefighters.

The workshop in the South zone took place from March 9 to 11, 2021 in Adétikopé in the prefecture of Agoè-Nyivé and brought together gunsmiths from three (3) regions:

-Grand Lomé ;

- Maritime Region;
- Region of Plateaux.

The Adétikopé workshop was opened by the Ministry of the Armed Forces, represented by the Chief of Staff of the Air Force, Colonel DJATO Tassounti in the presence of the Prefect of the prefecture of Agoè-Nyivé, Colonel AWATE Hodabalo and the Vice-President of the National Commission, Mr. BOURAIMA Inoussa.

The workshop in the North zone was held from April 13 to 15, 2021 in Kara in the Kozah prefecture and also involved agents from three (3) other regions:

- Central Region;
- Kara Region;
- Savannah Region.

This workshop was opened by the new President of the National Commission, Major General KADANGHA Abalo in the presence of the Prefect of Kozah, Colonel BAKALI Hemou Badibawu and the Vice-President of the National Commission, Mr. BOURAIMA Inoussa.

The themes presented during the workshops are as follows:

- Overview of the Arms Trade Treaty;
- International instruments on the management of stocks of arms and ammunition;
- Classification of weapons;
- Possible causes of pyrotechnic accidents;
- Management of arms stocks (guide to procedures, accounting, inventory, data conservation, register, transport, etc.).

During each workshop, the various participants were subjected to a practical exercise (at Camp Général Gnassingbé EYADEMA and Camp Général AMEYI) and an evaluation questionnaire.

- The reports of the work of the two (02) workshops (Adétikopé and Kara);
- analyzes of the evaluation questionnaires of the said workshops.

In general, the following results were obtained following the realization of the two workshops:

- Better assimilation of new techniques for managing stocks of arms and ammunition by officers in charge of arms and ammunition;
- Improvement of the degree of responsibility of the agents in charge of the management of stocks of arms and ammunition;
- Better assimilation of the risk prevention process related to the management of arms and ammunition stocks (diversion of arms and ammunition, self-ignition of storage places, etc.);
- - Better improvement of the chain of coordination of arms and ammunition management services.

b Describe how the project has assisted your implementation of the ATT.

The implementation of this project (training workshops on the safe and secure management of stocks of arms and ammunition) contributes to the domestication of the ATT in Togo through the various lines of intervention recommended, in particular the improvement of the legal framework, capacity building, training on specific issues such as stock management, reporting, national checklist, risk assessment (gender mainstreaming) and transit / transhipment, etc.

The two (2) workshops carried out as part of the implementation of this project allowed a better knowledge of the Arms Trade Treaty (ATT) for some participants and a discovery for others from the documentation updated. The arrangement of the participants and of a theme (Overview of the Arms Trade Treaty) on the agenda.

The same applied to other specific topics related to stockpile management such as: international instruments on the management of arms and ammunition stocks; classification of weapons; the possible causes of pyrotechnic accidents; the inventory management procedures guide (accounting-inventory-data retention-register-transport-etc.).

In view of the relevance of the project, several recommendations were made during the two (2) workshops to perpetuate the achievements and consider new perspectives in the matter:

- the need to strengthen the capacities of the Firearms and Ammunition officers (TAM) of the various units;
- the need for periodic retraining of gunsmiths;
- the importance of psychotechnical and polygraph tests before any recruitment to the position of gunsmith;
- destruction of end-of-life or unnecessary / obsolete weapons and ammunition and seized;
- the needs for rehabilitation / construction of stores for the storage and physical securing of weapons;
- initiating the sharing of experiences on the mechanisms for managing stocks of arms and ammunition in the different units.



Le projet a permis d'abord de combler les manquements par rapport aux procédures de gestion des armes relevés au niveau des armuriers et des magasins, ensuite de corriger les dysfonctionnements de la chaîne de coordination et enfin de contribuer à envisager des pistes de solutions à mettre en œuvre pour une meilleure sécurisation des stocks.
